Your rights:

If you have granted your consent, you have the possibility to revoke this consent at any time with effect for the future. This revocation will not influence the prior processing of data.

According to valid data protection legislation, you have the following rights: a) To view your personal data; b) To call for the correction of your personal data; c) To request the deletion of your personal data; d) To call for restrictions during processing of your personal data; e) To request the transfer of your personal data; f) To object to processing of your personal data.
